A Letter From The Alumni President

Dear brother,

Cornell DU—both the undergraduate brothers and alumni—continues to make steady progress on many initiatives in the second year of operation since our recolonization in 2003. You will sense this positive momentum as you read the various articles and look at the pictures in this *Noose*.

The chapter elected its second executive board of new officers in November to lead the house during this spring and next fall semesters. They are all enthusiastic about their new responsibilities and working well together to provide overall leadership of the house. The number of brothers is continuing to grow with the initiation in December of four more new DUs, who are profiled in a separate article on page five of this issue.

Another 14 associate members accepted DU bids in January's recruitment. With this class' initiation on Saturday, April 9, at 4:00 p.m., our DU chapter will have 50 brothers. We spent Saturday with many of the officers attending the annual A.D. White Leadership Conference sponsored by the

Office of Fraternity and Sorority Affairs. Then on Sunday, we had a very productive retreat with the officers reviewing and assessing all our efforts to date including the seven areas mentioned in my letter in the fall *Noose*. We also identified needed improvements, set action plans, and discussed goals and objectives for Cornell DU's future. Everyone left feeling that it was time well spent! At Sunday night's house meeting, which I attended, Bart VanStekelenburg '06 and each officer reviewed the aspects of the retreat that pertained to each of his position.

Dan Gilroy '86 has devoted a lot of time and thought to the development of our alumni mentoring program. Both Dan and John Honchariw '06 wrote separate articles in the fall *Noose* announcing this important alumni initiative. Please respond if you can help with any of the undergraduates' specific needs or if you want to get involved mentoring one or more of your DU brothers. You'll have a very rewarding experience.



Successful completion of our capital campaign ensures that the 133-year history of DU at Cornell will continue throughout the 21st Century. In the past two years, your directors have reestablished a vibrant undergraduate chapter and have totally restored the house to pristine condition. Our campaign will repay the debt incurred on our investment in improvements and fund on-going preventive maintenance and chapter programs in scholarship, education, and philanthropy.

Tom MacLeod '70 Takes Home Prestigious Ivy Football Award

There are many of us who admire the classic model of the all-American athlete—not those given the moniker “All-American athlete” by the *Associated Press* or *Sports Illustrated*, but those who truly embody the characteristics. The all-American athlete is the individual who works hard to cultivate his given athletic talents and, more importantly, respects and values others. He holds himself to a higher benchmark and contributes to make his world a better place.

We, the Cornell Chapter of Delta Upsilon, have our own all-American, and we were privileged to recognize and honor him at a recent gala event at the Waldorf Astoria in New York. Our all-American is Tom MacLeod '70.

Tom was among a very distinguished group of eight former Ivy League football players who were celebrated by the Ivy Football Association on January 27, 2005.

The Ivy Football Association, formed about six years ago, is a collection of Ivy football alumni who gather together to support and promote the values represented by the Ivy League football experience. The centerpiece of the association is the biannual football dinner, which honors former Ivy players who have moved from their days as players to further successes and preeminence in their chosen professional fields.

Each school presents its honoree, and this year's group included such notables as: Jeffrey Immelt, Dartmouth '78, chairman and CEO of General Electric; Billy Campbell, Columbia '62, chairman of Intuit, Inc.; Robert Ehrlich, Princeton '79, governor of Maryland; Charles Johnson, Yale '54, chairman of Franklin Resources; and, of course, our own Tom MacLeod, Cornell '70, chairman and CEO of Life Measurement, Inc. This was clearly an elite group of very successful men, and Tom stood tall among them. He truly represents Cornell and DU in a manner of which we can be extremely proud.

The dinner was the third such event held by the association to date and was

attended by over 1,200 people in the Grand Ballroom of the Waldorf.

Prior to the dinner, Tom was the featured guest at a private reception sponsored by the Cornell Football Association (CFA), and it was truly a warm and magical event. It was attended by over 130 of Tom's friends and teammates—including about 35 DU brothers from all over the country. While we all know the bonds of loyalty and love that exist within the DU brotherhood, on this night those feelings were truly palpable within the group. It was as if we were all from the same class and team; friendship was unaffected by the passage of time. It was the embodiment of the DU spirit.

Tom's story is defined by dedication to the highest standard, hard work, single mindedness, belief in self, and valuing others. Athletically, Tom was a success in two sports at Cornell. As a two-year starter at safety, Tom's career was highlighted by four interceptions and one touchdown. He was also named the recipient of

the Victor Grohman Scholar Athlete Award in his senior season.

His baseball career was even bigger. As captain of the Big Red, he was named to the first team All-Eastern Intercollegiate Baseball team. His toughness and strong will were evidenced by the fact that he set Big Red records for games pitched in a season and innings pitched in a game (12!). Tom is also a charter inductee into the Cornell Athletic Hall of Fame.

Tom's academic performance was as brilliant as his athletic credentials. He graduated with a B.S. in economics in 1970 and an MBA in 1971. His professional career has long been marked by consistent success, having moved from marketing head of Wilson Golf to head of international business for Wilson. This was followed by a very successful stint as president of PepsiCo Canada and further accomplishments as CEO of Sara Lee Bakery Worldwide. Perhaps his crowning achievement was the critical role he played as CEO in the phenomenal success of the Iams Company, a global

leader in the manufacturing of nutrition products for dogs and cats. This highly successful part of his career was culminated by his pivotal role in negotiating the sale of the company to Proctor and Gamble in 1999. Tom is currently chairman and CEO of Life Measurement, Inc., based in Concord, California. Can there be any doubt as to where this company is headed?

Despite his numerous successes in the corporate world, Tom has higher priorities. His world is anchored by his long and successful marriage to his lovely wife, Barbara. As partners and founders of the Cardinal Foundation, Barbara and Tom have been generous with their time and funds in support of many needy causes, such as the Ronald McDonald House, Catholic educational charities, and other causes.

An accomplished photographer, Barbara has directed the publication of a book featuring her photos of Ronald McDonald facilities around the world. Tom and Barbara are blessed with a fine son, Tom Jr., a former quarterback and graduate of Penn—Cornell's loss, hats off to Penn; he would have made a great DU. The good news is that he is still a member of our family.

One of the true highlights of this great evening was the presence and participation of Tom's father, who is truly a man of intelligence and dignity. It is readily apparent as to where Tom's success is rooted.

It was a great night for Tom, but perhaps even greater for Delta Upsilon. Tom MacLeod embodies the genuine spirit and ideals that we as people and DU brothers strive for. We are privileged to be Tom's brothers, and we were fortunate to be part of Tom's life again for that glorious evening.
